Any exceptions to the conditions of the above contract are subject to coach and Board approval and must be presented in writing. **All swimmers and parents MUST sign the Athlete Code of Conduct and all Parents MUST sign the Parent Code of Conduct.**

*I further understand that this contract obligates me to make payment for the entire amount indicated regardless of whether my child chooses to swim the entire Short Course season or participate in all available practices. Any requests for exceptions to the conditions of the above contract are subject to Head Coach and Board approval and must be presented in writing.*
