I understand that the Board and Coaches of LSSC can at any time remove my child from practice or from the team for disciplinary reasons or non-payment of fees. I understand that if my child is removed from practice or from the team I will be awarded no refund. I understand that the payment fees specified above are based on training groups. However, in the event that my child is moved into a training group other than the group they originally began in, I will agree to pay the fees associated with that training group. In addition to the requirement that my child be a current registered member of USA Swimming, I understand that I must have a medical release form on file. Any exceptions to the conditions of the above contract are subject to coach and Board approval and must be presented in writing. **All swimmers and parents MUST sign the Athlete Code of Conduct and all Parents MUST sign the Parent Code of Conduct (if swimmer is under age 18).**

I further understand that this contract obligates me to make payment for the entire amount indicated regardless of whether my child chooses to swim the entire Short Course season or participate in all available practices. Any requests for exceptions to the conditions of the above contract are subject to Head Coach and Board approval and must be presented in writing.
